6 BACKGROUND (Why is this Action Necessary, and What Action will be accomplished)

This is for the safety mowing of roadway rights-of-way, easements, and drainage facilities at various locations throughout Charlotte County. The bid was divided into three sections: A (North County); B (South County); and C (West County), with the option of awarding in total or by section. The lowest responsive, responsible firm for Section B (South County) is Arbor One, Inc., at the overall cost of \$126,350; for Section A (North County), it is Florida Mowing and Landscape Services at the overall cost of \$534,455.40; and for Section C (West County), it is Florida Mowing and Landscape Services at the overall cost of \$294,384. It is in the best interest of the County to award Bid #06-357 as stated above, at the unit prices listed on the attached, for the term October 1, 2006, up to and including September 30, 2007, with option to renew for two additional one-year terms, by mutual consent.
