The Parks Recreation and Cultural Resources Department has requested the establishment of a firm price annual contract for the purpose of tree removal, tree trimming and stump grinding. These services will include, but are not limited to, all Charlotte County Park locations and various other locations not covered in the Grounds Maintenance Contracts, and shall allow other Charlotte County Departments to utilize these services on property owned by the County. The establishment of the Contract shall also allow the County to respond to any "catastrophic wind event" as required by the awarded Contractor.

Therefore, it has been determined to be in the best interest of the County to recommend award to the overall lowest, responsive, responsible bidder, All Florida Tree & Landscape, Inc., of West Palm Beach, FL at the unit costs submitted.
